Subject: Up-gradation of educational qualifications for the posts of Clerks, Steno -typists and Stenographers.

Sir/Madam

I am directed to refer to the Government letter No. 42/71/88-5GSI, dated 5th February, 1992 whereby the qualifications for the posts of Clerks, Steno-typists and Stenographers for the Government departments were amended and it was requested to accordingly amend the Departmental Service Rules Further, vide Government letter No. 42/08/2008-5GSI and 42/08-A/2008-5GSI, dated 10th February, 2010, the qualifications were upgraded from Matric to Graduation for the posts of Clerks, Steno-typists and Stenographers respectively. It was also requested to amend their relevant service rules within a period of two weeks positively under intimation to the State Government. It has come to the notice of the State Government that only a few departments have so far implemented the instructions issued vide letter dated 05.02.1992.

In view of the above position Government has reconsidered the matter and decided that the Government instructions issued ibid vide dated 05.02.1992 and 10.02.2010 respectively may be kept in abeyance. It is further clarified that the qualifications for Clerks, Steno-typists and Stenographers would be the same as were obtaining prior to the instructions dated 05.02.1992.
