
Sir/Madam,

I am directed to refer to Government instructions issued vide letter No. 45/15/2004-5GSI, dated 31.08.2007 on the subject noted above vide which a blanket ban on transfer of all categories of employees was imposed till further orders.

2. On further consideration of the matter, it has been decided that the Ministers would be competent to effect transfers in their respective departments upto Class-II officers' level only, against vacant posts, on mutual basis and of officers /officials having stay of more than three years on one station. These instructions will be operative upto 31st July, 2010.

3. These instructions may be brought to the notice of all concerned for their information and compliance.




