I am directed to invite your kind attention to the above mentioned subject and to inform you that the National Commission for Scheduled Castes, New Delhi vide their letter No. 39/Misc-2/IGR Committee/2020/SSW-1, dated 29.07.2020(copy enclosed) has issued guidelines under article 338 of the Constitution of India for setting up Internal Grievance Redressal Committee at work place for persons belonging to Scheduled Castes community in Ministry/Departments level, State Govt. (Ministry/Department level) and also in the Public Sector Undertakings.

2. The Internal Grievance Redressal Committee will examine the complaints of the employees to find out the genuineness of the complaint and simultaneously the Committee will submit its report within one month to the Head of Organization. The Head of Organization will monitor the case and submit a quarterly report to the Commission.
3. Welfare of SC & BC Department being a Nodal agency of the State will ensure the implementation of these instructions.
4. You are, therefore, requested to take necessary steps to set up Internal Grievance Redressal Committee regarding Scheduled Castes community as desired by NCSC and submit monthly reports to Department of Welfare of Scheduled Caste and Backward Classes, Haryana.
5. These instructions may please be brought to the notice of all concerned for strict compliance.

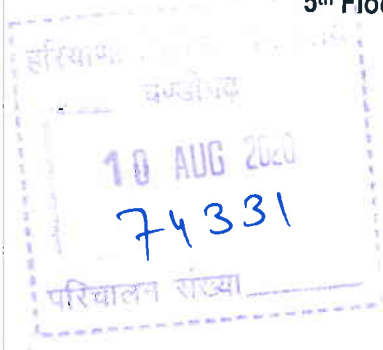

Subject: Setting up of Internal Grievance Redressal Committee at work place for persons belonging to Scheduled Castes community.

Sir/Madam,

In order to seek relief under Article 338 of the Constitution and keeping in view the safeguards provided to the SC persons, the employees approach to the Commission from time to time. The nature of complaints received in service division are (i) Non maintenance of reservation roster and not filling up of reservation vacancies, (ii) Discrimination in promotion/seniority/MACP/ACP, (iii) Non appointment/compassionate grounds, (iv) Downgrading of APAR's, (v) Termination /dismissal from services, (vi) Discrimination in transfer/posting (vii) Denial of pensionary benefits and disbursement of pay arrears etc. It has been seen that thousands of complaints are registered in the Headquarter besides the State offices. In the year 2019-20, more than 6500 complaints of service matters were registered in the Headquarters of New Delhi, besides thousands of cases were also registered in the state offices of NCSC.

To ensure active participation of various Govt. Departments in redressal of employment/ services related grievances of SC employees, Commission recommends that: An "Internal Grievance Redressal Committee" of 4-5 members be constituted by each at Govt. of India (Ministry/ Departments level), State Govt. (Ministry / Department level) and also in the PSUs. Suggested composition of the committee has been indicated as under:

(i)	SAG level officer of Department	Chairperson
(ii)	SAG level officers of External Department/NGO	Member (Scheduled Castes Member)
(iii)	Chief Liaison Officer/Liaison Officer (not below the rank of Director)	Member (SC Member)
(iv)	Director level Officer	Member (Having good knowledge of rules & procedure of Govt. of India)
(v)	One lady SC Officer of Director level	Member
