Sir/Madam.

I am directed to refer to the subject noted above as well as the instructions issued from time to time vide which all the departments were directed to clear the backlog of Physically Handicapped in the services of Haryana Government/Public Sector Undertakings/ Universities etc. In spite of that it is observed that the backlog of Physical Handicapped persons still exists in all the categories of PHCs in various Departments. The State Government is serious to clear the backlog of Physical Handicapped for group A to D posts in all the Departments.

The departments are, therefore, again requested to mark out the backlog of vacancies meant for Physical Handicapped and send their requisition to HPSC/HSSC/ Haryana Group D Employees Selection Committee within 20 days positively. The Haryana Public Service Commission/Haryana Staff Selection Commission/Haryana Group D Employees Selection Committee/Recruiting Agencies shall advertise the vacancies immediately and after completing all the formalities would recommend candidates as early as possible (approximately within three months). Action taken to this effect may also be communicated to this Department.
