Reservation of posts for physically handicapped persons under the services of State Government -HCS (Executive Br.) under Section 32 and 33 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995.

## Sir/Madam

I am directed to invite your attention to the subject noted above and to say that the State Government vide its letter No. 24/1/90-3GS-III. Dated 14.10.1992 had exempted Haryana Civil Services (Executive Branch) from the reservation of Physically Handicapped persons in direct recruitment. In pursuance of section 33 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (hereinafter called the Act) the Government has reconsidered the matter and has decided to provide reservation for physically disabled persons in Haryana Civil Services (Executive Branch) cadre also.

- Therefore, in continuation of Government instructions issued vide letters No. 22/36/90-3GS-III. dated 24.1.1991, No. 22/36/95-3GS-III dated 20.7.1995 and in pursuance of section 33 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, it has been decided to reserve 3% (three per cent) of posts of which 1% for each category i.e. blindness or low vision, hearing impairment and locomotor disability or cerebral palsy for direct recruitment in Haryana Civil Services (Executive Branch). The roster points already prescribed i.e. 26, 52 and 82 will remain undisturbed as fixed vide Government letter dated 24.1.1991.
