Subject: Regarding to withdrawal of Government instructions regarding grant of extension in service beyond the age of superannuation in respect of Differently-abled and Blind employees.

Sir/Madam,

I am directed to refer to notification No. 11/58/2023-1FR/27758 dated 3rd February, 2026, issued by the Finance Department, whereby the relevant provisions contained in Rule 143 of the Haryana Civil Services (General) Rules, 2016 — namely sub-rule (1), clause (i), clause (ii), Note 1 and Note 3 — have been omitted.

2. Accordingly, the matter has been reconsidered by the State Government, and in view of the above said notification, it has now been decided to withdraw, the following instructions issued regarding grant of extension in service beyond the age of superannuation in respect of differently-abled and blind employees:
