I am directed to invite your kind attention to this Department's letter of even number dated 21.07.2026, whereby the timeline was prescribed for verification of the records of eligible contractual employees by the Heads of Departments under the Haryana Contractual Employees (Security of Service) Act, 2024 and Rules, 2025.

Now, the State Government has decided to **extend the timelines** of the web portal (www.securedemployees.csharyana.gov.in) under the Haryana Contractual Employees (Security of Service) Act, 2024 and Rules, 2025, in respect of the following categories of contractual employees:

- Computer Faculty (School Education Department);
- Computer Lab Attendants (School Education Department);
- Contractual employees engaged through D.I.T.S. (excluding HARTRON);
- Contractual employees of the Haryana Staff Selection Commission (HSSC).

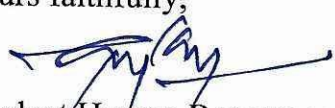
Accordingly, the revised schedule for completion of the process at various stages shall be as under:

Sr. No.	Particulars/Stage	Revised Timeline
1.	Registration of candidates on the portal	Up to 07.08.2026
2.	Verification by the respective Drawing & Disbursing Officers (DDOs)	Up to 14.08.2026
3.	Verification by the respective Heads of Departments (HoDs) on applications received from the DDOs	Up to 21.08.2026

Above mentioned departments are requested to ensure strict adherence to the above-mentioned schedule and complete the entire process within the prescribed timelines. Any delay in completion of the process shall be viewed seriously.

These instructions may kindly be brought to the notice of all concerned for strict compliance in a time-bound manner.
