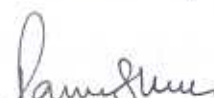

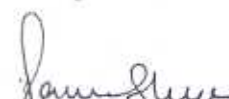

MINISTRY OF TOURISM INVITES APPLICATIONS FOR THE POST OF CHAIRMAN & MANAGING DIRECTOR, ITDC

- India Tourism Development Corporation Limited came into existence in October 1986 with the main objective of expansion of tourism infrastructure in the country. Presently, it has a network of eight Auhok Group of Hotels, six Joint Venture Hotels, 2 Restaurants (including one Airport Restaurant), 11 Transport Units, one Tourist Service Station, 2 Duty Free Shops and two Sound & Light Shows. The Chairman & Managing Director, ITDC has overall control over the day-to-day activities of the ITDC. The C&MD shall exercise such powers as may be prescribed.
- Applications are invited from eligible Indian citizens for appointment to the post of the Chairman & Managing Director, ITDC.
- The method of recruitment would be by direct recruitment (on contract basis). Candidates already serving in Government/Autonomous Bodies/Statutory Bodies/Universities etc. can also opt for appointment on deputation basis. For eligibility for appointment on deputation, applicants should be either working in analogous posts on regular basis or working in the scale of Rs. 37,400-67,000 (revised) with grade pay of Rs. 10,000/- with 3 years regular service in that scale, and possessing the qualification and experience as laid down.
- The following are the terms and conditions for the post of Chairman & Managing Director, ITDC:-

- Scale of Pay**
The post carries Schedule 'B' scale of pay of Rs. 75000-90000 (w.e.f. 1.1.2007) plus Industrial DA or Pay Band 4, scale of pay Rs. 37,400-67,000, Grade Pay Rs. 10,000/- plus Central DA. The incumbent will be eligible for Staff Car for official and personal use subject to the conditions laid down by the Department of Public Enterprises from time to time. The incumbent would be allowed HRA to the tune of 30% of the basic pay or a company/leased accommodation as per DPE guidelines. The post will also carry performance related pay as per DPE's OM No.3 (70/08-DPE (WC) dated 28.11.2006). In addition, there may be certain other allowances which would be decided by the Board of Directors.
- Terms & Conditions**
The C&MD will be governed by the terms and service conditions as per the guidelines issued by DPE from time to time. The C&MD shall be a full time incumbent.
- (a) Essential Qualification**
Graduate with good academic record from a recognized University/Institute.
- (b) Experience**
He/she should have adequate experience of management in the hospitality sector at the board level or one level below, in a company listed in the stock exchange and having a minimum annual turnover of Rs. 100 crore (to be supported by relevant documents).
- (c) Public Sector Executives:-**
Eligibility pay scales
(A) Below Board Level Executives: Rs. 7250-8250 (IDA) or Rs. 8500-11500 (IDA) (post 1.1.1992) or Rs. 20500-28500 (IDA) (post 1.1.1997) or Rs. 51300-73000 (IDA) (post 1.1.2007) or
(B) Board Level Executives: Rs. 7500-8500 (IDA) or Rs. 10000-12000 (IDA) (post 1.1.1992) or Rs. 22500-27300 (IDA) (post 1.1.1997) or Rs. 65000-75000 (IDA) (post 1.1.2007).

- On the date of vacancy, the applicant should have had 2 years experience (relaxable to one year experience in case of internal candidates) in the above scales.
- Government Officers:-**
a) The post of C&MD, ITDC has been exempted from the 'rule of immediate absorption' for a period of five years.
b) The eligibility criteria for candidates working in the Government "working at the level of Joint Secretary with three years in the scale of Rs. 37,400-67,000 (revised) with grade pay of Rs. 10,000/- or above in the Government of India or equivalent post".
Persons preferably with technical/MBA/Diploma in Hotel Management and familiarity with finance, marketing/production will have added advantage. Knowledge of hotel management/tourism development sector is desirable.
The minimum age limit is 45 years while the maximum age limit is 55 years for internal candidates and 55 years for others. Presently, the age of superannuation is 58 years.
The appointment will be for a period of five years or till the date of superannuation whichever is earlier. Incumbent shall be eligible for second term by way of renewal on good performance for another five years or till the date of superannuation, whichever is earlier. There shall be a performance review after a year of the first term of 5 years for confirmation of appointment.

2. A Search Committee has been constituted for selecting a suitable candidate for the post of C&MD, ITDC. This committee is empowered to consider any other names.
