Posting of Land Acquisition Officers in the State. Subject:-

Sir.

I am directed to refer to the subject noted above and to say that prior to 10.09.2008, HCS officers were posted by the Personnel Department on the following five posts of Land Acquisition officers of the HCS (Executive Branch) cadre which was determined vide order No. 43/4/2008-6SII, dated 13.8.2008:-

- Land Acquisition Officer., Urban Estate, Panchkula
- Land Acquisition Officer, Urban Estate, Gurgaon 2.
- Land Acquisition Officer, Urban estate, Faridabad 3.
- Land Acquisition Officer, PW (B&R) Ambala 4
- Land Acquisition Officer, PW (B&R), Hisar
- The Government reviewed the matter and vide its U.O. No. 43/4/2008-2. 6SII, dated 10.9.2008 decided that there would be ten posts of Land Acquisition Officer for the work of the land acquisition in the State as under:-
 - Land Acquisition Officer, Panchkula (for the districts of L Panchkula, Yamuna Nagar and Ambala)
 - Land Acquisition Officer. Hisar (for the districts of Hisar and 2. Bhiwani)
 - 3. Land Acquisition Officer, Gurgaon (for the districts of Gurgaon and Mewat)
 - Land Acquisition Officer, Faridabad (for the districts of 4. Faridabad and Palwal)
 - 5. Land Acquisition Officer, Rohtak (for the districts of Rohtak and Jhajjar)
 - Land Acquisition Officer, Rewari (for the districts of Rewari and 6. Mahendragarh)
 - Land Acquisition Officer, Sirsa (for the districts of Sirsa and 7. Fatehadbad)
 - Land Acquisition Officer, Kaithal (for the districts of Kaithal and 8. Jind)
 - Land Acquisition Officer, Karnal (for the districts of Karnal and 9. Kurukshetra)
 - Land Acquisition Officer, Panipat (for the districts of Panipat and 10. Sonepat)

It was also decided that the posts of Land Acquisition Officer, Faridabad, Gurgaon,

Hisar, Panchkula and Rohtak would be manned by the HCS officers and the posts of Land Acquisition Officer, Rewari, Sirsa, Kaithal, Karnal and Panipat would be manned by District Revenue Officers.

- 3. The Government vide U.O. No. 43/4/2008-6SII, dated 24.12.2008 also decided that the Land Acquisition Officers posted on Gurgaon, Faridabad, Rohtak, Panchkula and Hisar will be reserved for the Urban Estate Department and work under the administrative control of the Urban Estate Department. In addition, these Land Acquisition Officers would look after the land acquisition work pertaining to other departments in their respective area of jurisdiction. The Land Acquisition Officer, at Rewari, Sirsa, Kaithal, Karnal and Panipat would look after the land acquisition work pertaining to various departments in their respective areas of jurisdiction. They would work under the direct supervision of Deputy Commissioners concerned.
- 4. The Government has further reviewed the matter and decided to restore the system of Land Acquisition Officer's postings obtaining prior to 10.09.2008 so that their functioning is streamlined. You are, therefore, requested to take necessary action accordingly.
