In exercise of the powers conferred by Rule 45 of the Fundamental Rules and all other powers enabling him in this behalf, the Administrator, Union Territory, Chandigarh, hereby makes the following Rules further to amend the "Government Residences (Chandigarh Administration General Pool) Allotment Rules, 1996" namely:-



1. (i) These rules may be called the "Government Residences (Chandigarh Administration General Pool) Allotment (Amendment) Rules, 2020".

(ii) They shall come into force from the date of their publication in the Chandigarh Administration Gazette.

2. In the Government Residences (Chandigarh Administration General Pool) Allotment Rules, 1996 (hereinafter referred to as the Rules), in rule SR-317-AM-9, after the clause of (ix) and in rule SR-317-AM-6 after the sub rule (3) the following shall be added namely:-

"There will be no extra priority for officers coming from outside. They can get houses as per their seniority in their entitled category or a category below. They can also avail transit accommodation facility. The rules of Govt. of India will be followed"
