In exercise of the powers conferred by Rule 45 of the Fundamental Rules and all other powers enabling him in this behalf, the Administrator, Union Territory, Chandigarh, hereby makes the following Rules further to amend the "Government Residences (Chandigarh Administration General Pool) Allotment Rules, 1996" namely:-

1. (i) These rules may be called the "Government Residences (Chandigarh Administration General Pool) Allotment (Amendment) Rules, 2020".

(ii) They shall come into force from the date of their publication in the Chandigarh Administration Gazette.

2. In the Government Residences (Chandigarh Administration General Pool) Allotment Rules, 1996 (hereinafter referred to as the Rules), in rule SR-317-AM-3, Sub Rule (4) is hereby replaced as under:-

"There will be no special consideration for cases, where both the spouses are working in Government. The working couple can decide the spouses, who will apply for the house and will get it as per his/her seniority. The rules of Govt. of India will be followed"

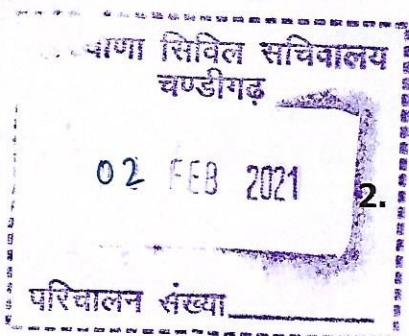
