 - “सामान्य प्रशासन विभाग (मुख्य सचिव के माध्यम से)” शीर्ष के नीचे उप-शीर्ष “(ज) नागरिक संसाधन सूचना” के नीचे, क्रम संख्या 6 तथा उसके सामने प्रविष्टियों के बाद, अन्त में, निम्नलिखित क्रम संख्या तथा उसके सामने प्रविष्टियां जोड़ी जाएंगी, अर्थात् :-

“7. हरियाणा राज्य सुदूर संवेदन अनुप्रयोग केन्द्र ।”, तथा
 - “सिंचाई तथा जल संसाधन विभाग (सचिव, हरियाणा सरकार, सिंचाई तथा जल संसाधन विभाग के माध्यम से)” शीर्ष के नीचे, क्रम संख्या 15 तथा उसके सामने प्रविष्टियों के बाद अन्त में, निम्नलिखित क्रम संख्या तथा उसके सामने प्रविष्टियां जोड़ी जाएंगी, अर्थात् :-

“16. लघु सिंचाई योजना ।”।

No. 6/4/2020.-1Cabinet.— In exercise of the powers conferred by clauses (2) and (3) of article 166 of the Constitution of India, I, Satyadeo Narain Arya, Governor of Haryana, hereby make the following rules further to amend the Business of the Haryana Government (Allocation) Rules, 1974, namely:-

1. These rules may be called the Business of the Haryana Government (Allocation) Fourth Amendment Rules, 2020.
2. In the Business of the Haryana Government (Allocation) Rules, 1974, in the Schedule,-
 - (i) under heading "AGRICULTURE AND FARMERS WELFARE DEPARTMENT (Through the Secretary to Government, Haryana, Agriculture and Farmers Welfare Department)" Serial Number 18 and entries thereagainst shall be omitted ;
 - (ii) under heading "GENERAL ADMINISTRATION DEPARTMENT (Through the Chief Secretary)", under sub-head "(H) Citizen Resources Information", after serial number 6 and entries thereagainst, the following serial number and entries thereagainst shall be added at the end, namely :-
 - "7. Haryana State Remote Sensing Applications Center." ; and
 - (iii) under heading "IRRIGATION AND WATER RESOURCES DEPARTMENT (Through the Secretary to Government, Haryana, Irrigation and Water Resources Department)", after serial number 15 and entries thereagainst, the following serial number and entries thereagainst shall be added at the end, namely :-
 - "16. Minor Irrigation Scheme."
