Subject: Entry of vehicles in vicinity of Haryana Civil Secretariat through parking stickers.

Sir,

I am directed to address you on the subject noted above and to say that entry of vehicles (official/private) into Haryana Civil Secretariat Complex has been replanned.

Accordingly, car parking stickers are to be issued for the official cars and private self driven cars of the officers/officials.

2. The cars of Ministers/Senior officers of the Secretariat would be parked in front of the Secretariat car parking area for which round numbered car parking stickers of red colour would be issued. Other officers i.e. Chairmen/Managing Directors of Boards/Corporations/Heads of Departments/Deputy Secretaries etc. Joint Secretaries/ would be issued numbered square car parking stickers of green colour for entry into Secretariat. These officers would alight from their cars and then the cars would be parked in the car parking area in the rear of Secretariat near C.T.U. Bus Stand.

3. Car parking stickers have been got printed and are ready for collection. I am, therefore, desirous to request you to depute representatives of your Departments/Boards/Corporations to collect the car parking stickers from the Administrative
