 - (ii) under sub-head "(H) Citizen Resources Information", after serial number 7 and entries thereagainst, the following serial number and entries thereagainst shall be added at the end, namely:-
 - "(8) The Haryana Compulsory Registration of Marriage Act, 2008 (6 of 2008)."
