No. 28/01/2006-1HR-I - It is hereby notified that **10.05.2026 (Sunday)**, being the day of poll for the General Election to the posts of Mayors and Members of all wards of three Municipal Corporations, namely Ambala, Panchkula and Sonapat, and Presidents and Members of all wards of one Municipal Council, Rewari, and three Municipal Committees, namely Sampla (Rohtak), Dharuhera (Rewari) and Uklana (Hisar), as well as bye-elections to six vacant seats of Members, namely Ward No. 17 of Municipal council, Tohana (Fatehabad), Ward No. 13 of Municipal Council, Jhajjar (Jhajjar), Ward No. 11 of Municipal Committee, Rajound (Kaithal) Ward No. 08 of Municipal Committee, Taraori (Karnal), Ward No. 14 of Municipal Committee, Kaniana (Mahendergarh) and Ward No. 09 of Municipal Committee, Sadhaura (Yamuna Nagar) shall be observed as paid holidays in all Haryana Government offices, Boards/Corporations and Educational institutions under Section 135-B of the Representation of the People Act, 1951 in respect of those employees of the State Government who are registered voters of the above said areas, to enable them to cast their vote in the said elections.

It is further notified that employees/workers of factories, shops and private establishments located in Haryana, who are registered voters in the above-mentioned areas, shall also be allowed a paid holiday under Section 135-B of the Representation of the People Act, 1951 for the same purpose.
