4. Pay and Allowances

5. CRITERIA FOR SELECTION OF CVO

- (i) Officer to be appointed as a CVO with Government Organization should have a good working knowledge of various Acts, Rules, Regulations, and Administrative instructions applicable to various Government Departments/ Organizations to be able to discharge the role of CVO efficiently and in a just manner.
- (ii) An officer under consideration for the post of CVO should have "Very Good" or above grading in the APAR of the last 5 years and should have integrity "beyond doubt".

- (iii) For officers to be considered to be appointed as CVOs, no major penalty should have been imposed in their career as a result of disciplinary proceedings,
- (iv) No criminal charges pertaining to official duties be pending against the officers to be considered. However, criminal cases arising out of family disputes may not be made a basis of ruling out consideration of a particular officer as CVO.
- (v) No disciplinary proceedings for major punishment should be pending against the officer.
- (vi) Officers having past experience in Personnel, Legal and Public Procurement matters may be preferred. Similarly, past experience with the concerned organization may also be considered.
- (vii) An officer will not be considered for appointment as CVO/Vigilance Officer in an organization to which he/she belongs.
