

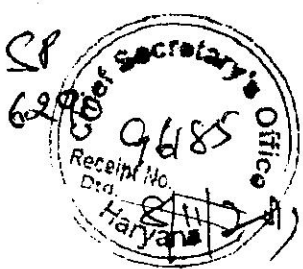

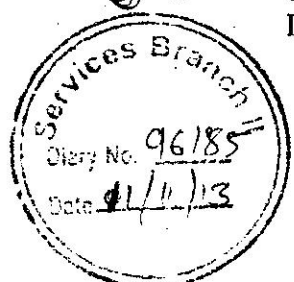

2. The candidates should be either in an analogous post, or have rendered at least 3 years regular service in the post of Assistant Registrar/Asstt. Legal Adviser or equivalent in the pay scale of Rs.37400-67000 + Grade Pay of Rs.8700/8900/- (Pre-revised scale Rs.10000-325-15200). Pay and other conditions of service of the selected officers will be regulated in accordance with the Department of Personnel and Training OM No. 2/29/91-Estt(pay-II) dated 5.1.1994 as amended from time to time. The maximum age limit for deputation shall be 56 years on the last date of receipt of application.

3. The application in respect of eligible officers, who can be spared in the event of selection may be forwarded after duly verified /countersigned by the Head of Departments alongwith the following documents:
