India Trade Promotion Organisation is a public sector undertaking under the administrative control of Ministry of Commerce and Industry, Govt. of India. It is a nodal agency for trade promotion of the country and maintains siate-of-the art exhibition complex, popularly known as Pragati Maidan, in New Delhi, Presently, plans are afoot to redevelop the complex.

- It is proposed to fill up one post of Officer on Special Duty (Administration) in ITPO initially for a period of three years on deputation basis. The post is at the level of General Manager (100000-260000 IDA E-7 scale). ITPO provides residential accommodation only on availability of ITPO's flats to the incumbent. The terms of deputation and allowances payable to the incumbent shall be regulated in accordance with the DOPT/DPE orders. The post is at the level of Director in Soverment of India.
