<sup>\*-</sup> The vacancy locations for NCSC are for the initial appointments only and the personnel may be posted/transferred in HQ or in any of the 12 State Offices of NCSC later, whenever required in public interest.

Note 1: The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation and similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed four years.

Note 3: The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

2. The selected officers will be on deputation for a period of <u>three years</u> initially which can be curtailed or extended further, depending upon the requirement, and with the consent of the officer and approval of the lending department. The usual deputation terms will apply. The selected officer will be posted with M/o Social Justice & Empowerment/ National Commission for Scheduled Castes.
