NOTIFICATION

New Delhi, the 29th May, 2017

G.S.R. 530(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the Professor and Assistant Professor in the National Fire Service College, Nagpur, under the Ministry of Home Affairs, namely:

- Short title and commencement.—(1) These rules may be called the National Fire Service College, Nagpur, Professor, Associate Professor and Assistant Professor (Academic Group 'A' Posts)
 - (2) They shall come into force on the date of their publication in the official Gazette.
- Number of posts, classification and the pay band and grade pay or pay scale. The number of post, its
 classification and the pay band and grade pay or pay scale attached thereto shall be as specified in
 columns (2) to (4) of the Schedule annexed to these rules.
- Method of Recruitment, age limit, qualifications, etc.—The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.



- Disqualifications.—No person, -
 - (a) Who had entered into or contracted a marriage with a person having a spouse living; or
 - (b) Who having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from operation of this rule.

- Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to
 do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public
 Service Commission, relax any of the provisions of these rules with respect to any class or category of
 persons.
- 6. Saving.—Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided to the Scheduled Castes, the Scheduled Tribes, Other Backward Class, Exservicemen and other special categories of persons in accordance with orders issued by the Central Government from time to time in this regard.
