CIRCULAR

Sub: Selection for the post of a Member in the Gujarat Electricity Regulatory Commission - Next arising vacancy to be filled-up from field of law - Invitation of Applications/Nominations- regarding.

Gujarat Electricity Regulatory Commission (GERC) has been constituted with a Chairperson and two Members.

The post of a Member, GERC is due to fall vacant w.e.f. 28-12-2019 (AN). For filling up of this post, a selection committee for obtaining the suitable names for the appointment, is being formed by the State Government. The State Government has, therefore, decided to prepare a list of the persons who would be interested to have their names for consideration of the Selection Committee.

In terms of Section 5 of the Gujarat Electricity Industry (Reorganization and Regulation) Act, 2003, the Member of the GERC shall be the person who has special knowledge and professional experience in the field of finance, commerce, economics, regulation of industry, law or management.

As per the Judgement of the Hon'ble Supreme Court of India dated 12.04.2018, a person of law as a Member of the Commission, shall be a person, who is or has been holding a judicial office or is a person possessing professional qualifications with substantial experience in the practice of law, who has the requisite qualifications to have been appointed as a Judge of the High court or a District Judge.

The term of office and conditions of service for the person finally selected for appointment on the post of Member, GERC, shall be as per the provisions of the Gujarat Electricity Regulatory Commission (Conditions of services of Members) Rules, 2003, as amended vide Gujarat Electricity Regulatory Commission (Conditions of services of Members) (Amendment) Rules, 2018 (Copies enclosed).

As provided under section 89 (1) of the electricity Act, 2003, the Member shall hold office for a term of five years from the date he/she enters upon his/her office. Provided further, that no Member shall hold office as such after he/she has attained the age of sixty five years.

It is requested to propose the names of interested and suitable persons for the post of Member, GERC along with their resume (indicating the age as on 31st October, 2019), and the same should reach on or before 2nd December, 2019, at the following address:

While forwarding the applications/nominations, it may kindly be ensured that the person proposed does not have any financial or other interests which is likely to prejudice his/her functions as Member, GERC.

The resume of proposed person should include the following details.

Name, age, date of birth, position now held, educational qualification, publication of any book or article on the subject earlier, details of posts previously held.

The proposal should also contain the details of any office held, employment, consultancy agreement or arrangement which he/she has in his/her own name or any firm, association of persons or body corporate or in the name of any relative, carrying on or related with any of the following business, namely:-

- i) Generation, Transmission, Distribution or Supply of electricity.
 ii) Manufacture, sale or complexity.
- ii) Manufacture, sale or supply of any fuel for generation of electricity.
- iii) Manufacture, sale, lease, hire or otherwise, supply of or dealing in machinery, plant, equipment, apparatus or fittings for the matters specified in (i) above, or
 iv) Any entity providing parts.
- iv) Any entity providing professional service to any business as referred above.

In addition to above, the person would have to give an undertaking that on appointment on the post of Member, GERC, he/she will resign from the post, he/she holds at present.
