- (a) (i) holding analogous posts on regular basis in the parent cadre or Department or
- (ii) with two years' service in the grade rendered after appointment thereto on a regular basis in posts in the Level 13A of the Pay Matrix (Rs.1,31,100-2,16,600/-) or equivalent in the parent cadre or department; or
- (iii) with three years' service in the grade rendered after appointment thereto on a regular basis in posts in Level 13 of Pay Matrix (Rs 1,23,100-2,15,900) or equivalent in the parent cadre or department; and
- (b) possessing the following educational qualification and experience as prescribed in the RR.

Essential -

- (i) Bachelors' Degree in Engineering or Technology (Mining) from a recognized University and
- (ii) **Fourteen (14) years'** experience in Coal Industry in the Government sector.

Desirable Qualifications:

- (i) Master's Degree in Engineering or Technology (Mining) or Masters in Business Administration.

Note I: The selection will be made in consultation with the UPSC.


Note II: The selected officers will be treated on foreign service/ reverse foreign terms and his pay will be regulated in accordance with the provisions contained in the Ministry of Finance (Department of Expenditure) O.M. No.F.10(24)E.III/60 dated 04th May, 1961 as amended from time to time read with Department of Personnel & Training's OM No. 6/8/2009-Estt (Pay.II) dated 17.06.2010 & OM No. 2/11/2017-Estt.(Pay-II) dated 24.11.2017 as the case may be and as amended time to time.

Note III: The period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation or Department of the Central Government shall ordinarily not to exceed 5 years. The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 56 years as on the closing date of the receipt of applications.
