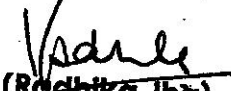

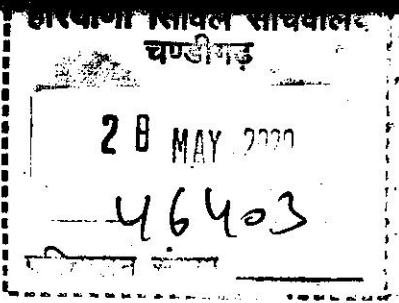

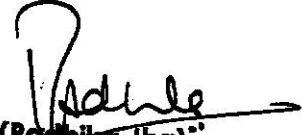
"84. Qualification for appointments of Chairperson and Members of State Commission :-
