The National Institute of Disaster Management require the services of suitable officers for filling up two posts of Associate Professor at its New Delhi campus on deputation (including short term contract) basis.

This post is classified as Group 'A' post in the pre-revised scale of pay Rs. 15600 - 39100 plus Grade Pay of Rs. 7600 (Level 12 as per pay matrix of 7th CPC).

The grades from which deputation (including short term contract) to the post of Associate Professor is to be made is as under:
