The post of Controller of Publications is a Group 'A' post in Level 12 in the Pay Matrix as per the 7th CPC [pre revised Pay Band-3 Rs.15600-39100/- (+) Grade Pay Fs.7600/-].

- 2. The Controller of Publications functions as a Head of the Department under the control of this Ministry and is vested with all statutory powers in that post on the matters related to finance, legal, disciplinary and administration. He would also be responsible for managing the work of stocking, distribution and sale of all official publications. The Headquarters is situated at Civil Lines, Delhi-110054.
- Officers under Central / State Governments / Union Territories / Universities / recognized Research Institutions / Public Sector Undertakings / Semi-Government or Autonomous and Statutory Organizations;-
- (a) (i) Holding analogous posts on regular basis in the parent Cadre or Department;
 OR
 - (ii) With five years of regular service in the grade rendered after appointment thereto on a regular basis in Level 11 in the Pay Matrix as per the 7th CPC [pre-revised Pay-Band 3 of Rs.15600-39100/- (1) Grade pay Rs.6600/-] or equivalent in the parent Cadre / Department; and

Possessing the following educational qualifications and experience:

Graduate Degree from recognized University / Institutions;

- (ii) Master of Business Administration / Post Graduate Diploma in Management / Post Graduate Degree in Printing Technology from a recognized University / Institution; and
- (iii) Possessing eight years experience in the field of Publication.

 - (i) The Armed Forces personnel of the rank of Lt. Colonel or equivalent who are to be transferred to reserve within a period of one year and having the

qualifications and experience prescribed for deputation shall also be considered. Such persons would be given deputation terms up to the date on which they are due for release from the Armed Forces; thereafter they may be continued on re-employment.

- 4. Period of deputation (ISTC) including period of deputation (ISTC) in another excadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall ordinarily not exceed four years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years' as on the closing date of the receipt of applications.
- 5. The pay of the selected candidates will be regulated in accordance with the Government of India Rules on the subject as amended from time to time.
