It has further been prescribed that the Chairperson of the State Commission shall not hold any other office.

As provided under Section 89(1) of the Electricity Act, 2003, the Chairperson shall hold office for a term of five years from the date he/she joins office. Provided further, that Chairperson shall not hold office as such after he/she has attained the age of sixty five years. The candidate will have to give a declaration that he/she does not have any financial or other interest, which is likely to affect prejudicially his/her functions as Chairperson, Rajasthan Electricity Regulatory Commission.

The terms of appointment shall be in accordance with the provisions of 2.2.21 Electricity Act, 2003 including the person appointed shall have to resign or opt for voluntary retirement from the services or organization to which he/she belongs.
