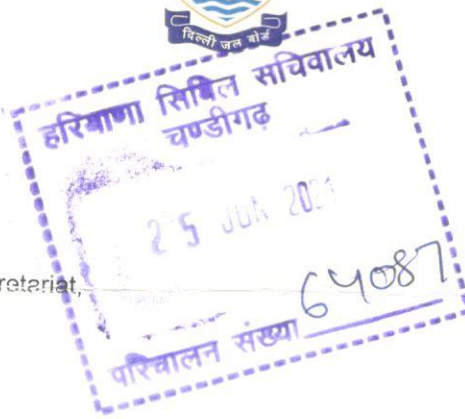

Subject : **Nomination as Member (Water Supply) and Member(Drainage) in the Pay Level-14 of Pay Matrix of Rs. 1,44,200-2,18,200 under 7th CPC in Delhi Jal Board.**

The Delhi Jal Board came into existence through a statutory legislation on 02.04.1998. The Delhi Jal Board is responsible for treatment and distribution of water supply, regulation and management of exploitation of groundwater in consultation with CGWA, collection, treatment and disposal of sewage etc within the National Capital Territory of Delhi.

The Delhi Jal Board proposes to fill up the post of Member (Water Supply) and Member (Drainage) on nomination basis.

Accordingly, applications are invited by Delhi Jal Board, Govt. of N.C.T of Delhi from eligible candidates for filling up the post of Member (Water Supply) and Member (Drainage) initially for a period of three years in the Pay Level-14 of Pay Matrix of Rs. 1,44,200-2,18,200 under 7th CPC by nomination from the employees of Central Government/ State Government/Union territory/ Public Sector Undertakings/ Organizations. As per section 3(2) (VII) and (VIII) of the Delhi water Board Act, 1998, the eligibility conditions for the post are as under:-

"A Member (Water Supply) is to be nominated by Government who shall be an Engineer, drawing pay not less than that of a Joint Secretary to the Government of India, having specialized knowledge and experience in the matters relating to water supply".

"A Member (Dr.) is to be nominated by the Government who shall be an Engineer, drawing pay scale not less than that of a Joint Secretary to the Government of India, having specialized knowledge and experience in the matters related to drainage".

I would request that these vacancies may be circulated amongst various departments/ organizations under your jurisdiction. The name of eligible and willing officers to serve as Member (Water Supply) and Member (Drainage) in Delhi Jal Board may be forwarded to the Member (Administration), Delhi Jal Board, Govt. of N.C.T of Delhi, Varunalaya Complex Phase-II, Karol Bagh, New Delhi-110005 by **29.07.2021 at 05:00 P.M.** The terms & conditions of nomination shall be the standard terms & conditions, as prescribed by the Govt. of NCT of Delhi. While recommending the names of the suitable candidates, their CVs, Vigilance clearance and ACR dossiers (for the last 05 year) may also be forwarded for consideration. The application format and other information is available on the website www.delhijalboard.nic.in.
