I am writing to you in connection with filling up the existing vacancies in the post of Technical Member, National Anti-Profiteering Authority (NAA) under the Department of Revenue.

- 2. Two posts of Technical Member, National Anti-Profiteering Authority (NAA) have become vacant vice Smt. R. Bhagyadevi w.e.f 28.11.2019 and vice Shri. J. C. Chauhan w.e.f 14.12.2020.
- 3. As informed earlier, as per Rule 122 of Central Goods & Services Tax Rules 2017, National Anti-Profiteering Authority (NAA) shall consist of Technical Members who are or have been Commissioners of State Tax or Central Tax for at least one year or have held an equivalent post under the existing law, to be nominated by the GST Council. Further, in terms of Rule 124(5) of the Central Goods & Services Tax Rules 2017, no person shall be selected as a Technical Member of the Authority if he has attained the age of 62 years; provided further that the Central Government with the approval of the Chairperson of the Council may terminate the appointment of the Technical Member at any time. The names of Chairman and four Technical Members of NAA will be recommended by a Selection Committee constituted under Rule 124(1) of the said Rules.
- 4. The vacancies in the post of Technical Member, National Anti-Profiteering Authority (NAA) were circulated vide this Department's letter F.No.A-12026/4/2021-Ad.I dated 24.02.2021, 06.04.2021 and 14.06.2021 amongst Chairman, CBIC and all Chief Secretaries of States for inviting applications from eligible and willing officers. Despite circulating the vacancies thrice, no response/nomination has been received till date and as a result of which the functioning of the Authority has been severely affected. It is imperative that the issue is addressed immediately.
- 5. I shall be grateful if you could kindly look into the matter personally and arrange to send in names of suitable officers against the two vacancies in the post of Technical Member, National Anti-Profiteering Authority (NAA), without further delay.
