Eligibility Criteria For the post of Deputy Director (Ministerial)

"Officers belonging to Central State Govt, holding analogous past or officers with 5 years of service in Level-10 in Pay Matrix as per 7th CPC or officers with 8 years' service in Level-8 in Pay Matrix as per 3th CPC or equivalent."
