The Ministry of Shipping invites applications to the post of Deputy Chairman in Jawaharlal Nehru Port Trust in the pay scale of Rs. 25,750-650-30,900/- (in industrial DA pattern). Apart from the salary, the post also carries the perquisites such as dedicated accommodation, transport, medical attendance, LTC etc. The Port Trust is an autonomous body governed under the Major Port Trusts Act, 1963. Officers belonging to All India Service and Central Services Group 'A', who have put in not less than 13 years of service in Group 'A' are eligible to be considered for this post. Having experience in Port and Shipping sector would be an added qualification.
