

Subject: Filling up of the post of Director General in the Competition Commission of India (CCI), New Delhi on deputation basis.

Sir,

I am directed to say that it is proposed to fill up the post of Director General in the Competition Commission of India, New Delhi, under the administrative control of the Ministry of Corporate Affairs. The particulars of the post, scale of pay, and the eligibility requirements, have been set out in Annexure-I.

The person selected will be appointed on transfer on deputation basis. The pay will be regulated in accordance with the Department of Personnel & Training's OM No.2/29/91-Estt (Pay-II) dated 05.01.1994, as amended from time to time. The period of deputation including the period of deputation in the same or some other organisation/department of the Central/State Government shall not ordinarily exceed three years. The maximum age limit for appointment on deputation basis shall be 56 years on the closing date of applications.

It is requested that this vacancy circular may kindly be given wide publicity and applications of eligible and willing officers, whose services can be spared immediately on selection, may kindly be forwarded through proper channel in the prescribed proforma at Annexure-II duly accompanied by the following documents, to Shri J. - (iv) Certificate to the effect that no major/minor penalties have been imposed on the official during the last ten years duly signed by an officer not below the rank of Deputy Secretary;
