

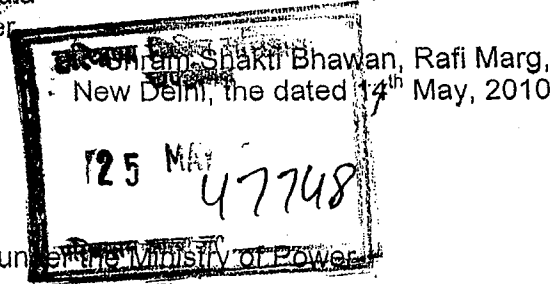

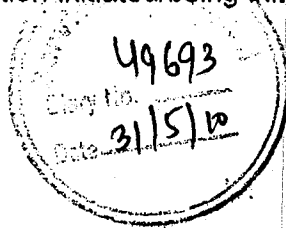
I am directed to say that the North Eastern Electric Power Corporation (NEEPCO) is a Schedule 'A' Public Sector Enterprise incorporated under the Indian Companies Act, 1956 with the objective to plan, promote, investigate, survey, design, construct, generate, operate and maintain hydro and thermal/gas power stations and to explore and utilize the power potential of the North Eastern Region in particular and also to improve socio-economic condition of the people of North Eastern Region by providing road communication, telecommunication, extending medical and education facilities, offering employment opportunity and promote of industrial growth. The authorized and paid capital of the company is Rs. 3500 crs. and Rs. 3197.76 crs. respectively as on 31.03.2009

As the post of CMD, NEEPCO has fallen vacant in Schedule 'A' scale of pay of Rs 80,000-1,25000/- (Revised w.e.f. 01.01.2007), it is proposed to make selection for this post by PESB.
