

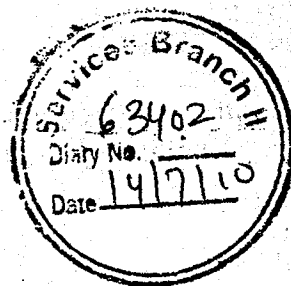
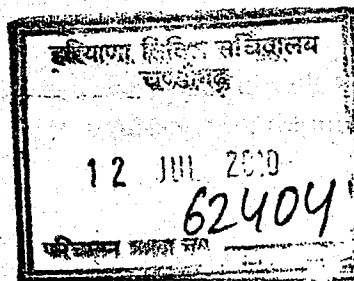

**Sub: Regarding sponsoring the names for appointment to the post of Asstt. Commissioner/Dy. Assessor & Collector on deputation basis in the MCD.**

Sir/Madam,

I am directed to say that there are 14 posts of Asstt. Commissioner/Dy. Assessor & Collector in the Pay Band-3 (Rs. 15,600-39,100+6,600 G.P.), which are required to be filled up on deputation basis in MCD. As per notified RRs to the post, **suitable officers of the Central Services Class-I and of State Civil Services are eligible for appointment to the post of Asstt. Commissioner / Dy. Assessor & Collector.** (The period of deputation ordinarily not exceeding 3 years)

Since, the MCD follows the Rules/Regulations/Instructions of the Govt.of India, the laid down terms and conditions of deputation of the Govt.of India shall be applicable *mutatis mutandis* to the officer on deputation basis.
