



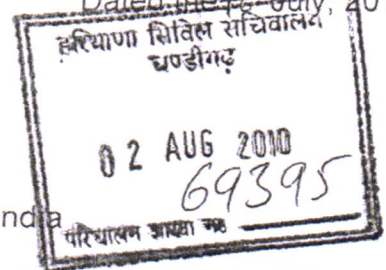

4-8-10 This is regarding filling up the post of Deputy Director (Administration) in the Project Cell of the AIIMS like Institution at Bhopal under the Ministry of Health & Family Welfare in the pay scale of Rs. 37,400 – 67,000/- + Grade Pay of Rs. 8700/-, on deputation basis.
