
It is proposed to fill up the post of General Manager [Zonal Office(North)], Food Corporation of India, Noida under the Department of Food & Public Distribution at Dy. Secretary/Director level .

2. Officers of the level of Dy. Secretary/Director in the Government of India or equivalent level, who are eligible for appointment under the Central Staffing Scheme can apply for the post. The period of deputation is 4/5 years for Dy. Secretary/Director respectively.

3. The post may be circulated amongst all the Dy. Secretary/Director level officers of the State Governments/Ministries/Departments of the Government of India on priority basis. 4. It is requested that the application of the eligible candidate(s) may please be forwarded so as to reach this department on or before 30.11.2010.



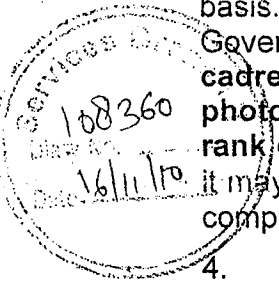
