Executive Directors in NAFED on deputation basis.**

National Agricultural Cooperative Marketing Federation of India Ltd (NAFED), an apex organization of marketing cooperatives in India having a turnover of around Rs.6000 crores, was established on 2<sup>nd</sup> October 1958 with the prime objective of providing marketing support to the farmers to help them fetch reasonable price for their produce. NAFED operates with its Head Office at New Delhi, four zonal offices located at Delhi, Chennai, Mumbai and Kolkata and 28 branches located in the state capitals and other important cities of India.

Registered under Multi-State Cooperative Societies Act, it functions as one of the nodal agencies of the Government of India for implementing price support scheme for pulses, oilseeds and cotton, canalizing agency for export of onion and one of the importing agencies for pulses and edible oil. It also undertakes procurement of agri-commodities in commercial account to provide better remunerative price to the farmers.

In view of Government of India's active consideration of financial and administrative restructuring of pNAFED, applications are invited for one post of Additional Managing Director from officers of All India Services at the level of Director. in the pre-revised pay scale of Rs. 15,450-850-32,450 and three posts of Executive Directors in the pre-revised pay scale of Rs. 14,200-800-30,200 and other perquisites (on deputation basis). Preference will be given to officers of All India Services at the level of Dy. Secretary and above.

The applicants should have minimum experience of 10 years for the post of AMD and 08 years in case of Executive Directors of working in similar capacity in Government Departments/Autonomous bodies/PSUs preferably in financial/marketing areas.
