It is proposed to fill up the post of Financial Advisor & Chief Accounts Officer in Central Administrative Tribunal, Principal Bench, New Delhi on deputation basis.

- The officers of the rank of Deputy Secretary/Director of the Government of India or equivalent level, eligible for appointment under the Central Staffing Scheme who have knowledge of Budget & Accounts works, are eligible for the post. The period of deputation is 4/5 years for Deputy Secretary/Director respectively.
- The post may be circulated amongst officers eligible to be appointed at Deputy Secretary/Director level or equivalent level in the Government of India on priority basis. Names of willing and eligible officers who can be spared by the State Governments/Ministries/Departments may be forwarded to this Department along with cadre clearance, vigilance clearance, detailed bio-data in the enclosed proforma and CR Dossiers for the last five years.
