- (b) Possessing the following educational qualifications and experience, namely:-
 - (i) Post Graduate Degree in any discipline from a recognized University or Institution; and
 - (ii) fifteen years' experience in dealing with Service, Administrative, Vigilance, Establishment and Financial matters.
- 4. <u>Period of Deputation</u>: The person appointed as Chairman of Staff Selection Commission shall hold office for a period of five years or till he/she attains the age of 65 years, whichever is earlier, provided that in case a serving officer appointed as Chairman, Staff Selection Commission retires on superannuation before completing the tenure of five years, he may be considered for appointment on re-employment terms for the remaining period of tenure subject to the upper age limit for 65 years.
- 5. Age Limit: The maximum age limit for appointment by deputation shall not be exceeding 59 years on 15 /04/2019.
