

This is in supersession of dircular of even number dated 28.08.2018 inviting applications for the post of minancial Adviser in NCLT under the Ministry of Corporate Affairs on deputation basis.

- Officers of the rank of Deputy Secretary/Director level from the All India Services and from the Organized Chous Alicentices of the Government of India, eligible for appointment under Central Staffing Scheme are eligible for the post. The period of deputation is 4/5 years at Deputy Secretary Alicenton level respectively.
- The post may be circulated ampagst officers eligible to be appointed as Deputy Secretary/Director in the Covernment of Iridia on priority basis. Names of willing and eligible officers who can be spared may be forwarded to this Department along with cadre clearance, vigilance clearance, detailed blo-data in the enclosed proforma and CR Dossiers for the last five years. - 4. The post is a Non-Central Staffing Scheme post to be filled up through the Civil Services Board (CSB) proceedure. It may be noted that no 'Mandatory Posting Certificate' for allotment/retention of Covernment accommodation would be issued by this office to the officer appointed of the labove referred post. However, those officers who have served and are currently serviced in Central Staffing Scheme post in Delhi for at least four years and require to retain Covernment accommodation, would be issued a certificate to the effect that the officer concerned in a commodation for his/her tenure on the non-CSS post.
