

This is in supersession of dircular of even number dated 28.08.2018 inviting applications for the post of Financial Adviser in NCLT under the Ministry of Corporate Affairs on deputation basis.

- 2. Officers of the rarik of Deputy Secretary/Director level from the All India Services and from the Organized Greup Alservices of the Government of India, eligible for appointment under Central Staffing Scheme are eligible for the post.
