Candidate should have a Post Graduate University degree preferably in Economics/Commerce/Business Administration or Finance or a Graduate degree with professional qualification of Chartered Accountancy, Cost Accountancy, Chartered Financial Analyst or equivalent. Minimum 18 years of experience as on the date of vacancy in different verticals/domains in Scheduled Commercial Banks (SCBs)/ Financial Institutions (FIs)/Public Sector Organisations in the financial sector including 2 years of operational experience preferably in International Finance/ Export Credit Appraisals.

(vi) Duration of Assignment:

The assignment shall be for a period of 3 years and may be extended by upto 2 years based on performance provided that no person shall hold office of DMD. EXIM Bank after attaining the age of 60 years. For All India Service officers/ Central Services Group 'A' officers, extant guidelines on deputation tenure shall apply.
