Sub: Regarding sponsoring the names for appointment to the post of Director (Primary Education) on deputation basis in the MCD.

Sir/Madam,

Applications are invited for filling one post of Director (Primary Education) in the pay of scale of Rs.14300-18300/-(pre-revised), on deputation basis in Municipal Corporation of Delhi from eligible and willing officers.

As per RRs to the post, officers of the All India Service/Central/State Government/ State Governments/ UTs, are eligible, subject to fulfillment of the following conditions:-

(a) i. Holding analogous posts on regular basis in the parent cadre/department;

ii. with five years service in the grade rendered after appointment thereto on a regular basis in the scale of Rs.12,000-16,500/-(Pre-Revised) or equivalent,

and

- (b) Possessing following educational qualifications and experience:-
  - (i) Master's degree from a recognised University or equivalent.
  - (ii) 12 years' administrative experience including 2 years' experience in the field of education in a responsible capacity.
