**Sub: Regarding sponsoring the names for appointment to the post of Director
(Primary Education) on deputation basis in the MCD.**

Sir/Madam,

Applications are invited for filling one post of Director (Primary Education) in the pay scale of Rs.14300-18300/- (pre-revised), on deputation basis in Municipal Corporation of Delhi from eligible and willing officers.

As per RRs to the post, officers of the All India Service/Central/State Government/ State Governments/ UTs, are eligible, subject to fulfillment of the following conditions:-

- (a) i. Holding analogous posts on regular basis in the parent cadre/department;
or
ii. with five years service in the grade rendered after appointment thereto on a regular basis in the scale of Rs.12,000-16,500/- (Pre-Revised) or equivalent,

and

(b) Possessing following educational qualifications and experience:-

- (i) Master's degree from a recognised University or equivalent.
(ii) 12 years' administrative experience including 2 years' experience in the field of education in a responsible capacity.

[Period of deputation including period of deputation in another cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall not exceed 5 years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of application].

Since, the MCD follows the Rules/Regulations/Instructions of the Govt. of India, the laid down terms and conditions of deputation of the Govt. of India shall be applicable *mutatis mutandis* to the officer on deputation basis. The pay scale mentioned above are pre-revised hence officer in the corresponding scales as prescribed in the VIth CPC would be eligible for the post.

It is, therefore, requested that the names of eligible, suitable and willing officers alongwith their Application, Bio-data, ACRs for the preceding five (5) years, Integrity Certificate, Vigilance Clearance and Cadre Clearance etc. may kindly be forwarded, within 60 days, so as to enable this office to select a suitable officer to be appointed as Director (Primary Education) on deputation basis.

This may kindly be given **TOP PRIORITY**.
