

OFFICE MEMORANDUM

Subject: Filling up the post of Deputy Director (Admn.), PGIMER, Chandigarh
— regarding

The PGIMER, Chandigarh is one of the premier autonomous institutions under the Ministry of Health & Family Welfare which has the mandate to provide high quality patient care, attain self sufficiency of post graduate medical Education and to meet the country's needs to have highly qualified and skilled medical teachers in medical sciences and to undertake basic community based research. The Institute has a post of Deputy Director (Admin), which has fallen vacant.

2. The post of Deputy Director (Admin) at PGIMER, Chandigarh is a non Central Staffing Scheme post in the pay scale of Rs. 37,400-67,000 (PB-4) with Grade Pay of Rs. 8,700/- p.m. is to be filled up on deputation basis for a period of 4 years through the Central Government as per the Recruitment Rules. Deputy Director (Admin) PGIMER is concerned with the administrative matters of the Institute in consultation with the Director of the Institute. The post also involves having a very close interaction with policies and programmes of the Government.

3. In terms of Recruitment Rules, the tenure is not specified. However, as per past practices, the tenure can be up to a maximum of 4 years. Ministry of Health & Family Welfare has obtained exemption from permanent absorption of the officers on deputation up to 31.3.2011 in PGIMER, Chandigarh from DP&PW. A suitable accommodation is also ear-marked for allotment to the incumbent of the post.

4. It is requested to forward names of suitable officers in terms of DoPT deputation guidelines, who are interested for being considered for the post along with up to date vigilance clearance as well as duly certified ACR gradings for the last five years, along with Cadre clearance / concurrence of State Government concerned on whose strength the officers are borne, so as to reach Under Secretary, ME (II) Division of Ministry of Health and Family Welfare, Nirman Bhawan on or before 20.12.2010.
