## INSTRUCTIONS

1. This form is applicable for the dependent of ex-servicemen applying for scholarship under the Amalgamated Fund.
2. All applications, duly completed in all respect, should reach the office of the Zila Sainik Board through the Heads of Institution by due date. No action will be taken on incomplete/late application.
3. Stipend will be sanctioned only for one academic year and it would be necessary to submit fresh application for the next year.
4. Scholarship for the Graduation course shall be given only to those who secure at least 50% marks.
5. No. Scholarship will be given for the Post Graduate studies in professional courses like M.Ed., M.Sc., Agr., M.Sc. Engineering, M.D. M.S. etc.
6. Stipend under these schemes is admissible to students studying in 9<sup>th</sup> and above classes.
7. Dependents/Wards of the following are not eligible hence they should not apply for stipends under these schemes :-
  - (i) Ex-officers of the Armed Forces;
  - (ii) Ex-serviceman who has been discharged from service on compassionate ground within five years of service. This excludes medically boarded out even within five years;
  - (iii) Ex-serviceman whose character at the time of discharge was assessed below Good;
  - (iv) “Dependent” means the wife, non-earning sons below the age of 21 years, un married or widowed daughters, non-earning brothers below the age of 21 years, non earning unmarried sisters and non-earning parents of ex-serviceman actually dependent on the ex-serviceman provided that in case of non-earning sons or brothers the age of 21 years may be relaxed upto 25 years in case such a son/brother is pursuing a Post Graduate or Technical Course which he cannot complete within the specified age;
  - (v) The parents/guardians of the applicant should have served in the Armed Forces continuously for a period of six months and above after completing their training recruitment period and are not charged with or convicted of an offence which in the opinion of the committee then should disqualify.
8. The terms Ex-serviceman does not include members of the following forces:-

- (i) Assam Rifles
  - (ii) Lok Sahayak Sena
  - (iii) General Reserve Engineering Force
  - (iv) Territorial Army
  - (v) Members of INA (for any assistance they should approach the Chief Secretary, Govt. of Haryana in Protocol and Publicity Branch, Haryana Civil Secretariat Chandigarh.
9. The stipend is allowed to one child of an Ex-serviceman where more than one is entitled the student eligible for higher rate of stipend is accommodated. The fact that no other brother or sister of the applicant is in receipt of stipend should be supported by an affidavit duly attested by an Oath Commissioner.

#### B.CONDITIONS APPLICABLE TO

- (I) Attested copies of discharge certificate of their parents/guardians when the fact of domicile is not mentioned in the discharge certificate, a certificate duly attested by a First Class Magistrate may be attached with the application confirming that the father/guardian of the applicant is bonafide resident of Haryana.
- (II) The dependents of Ex-JCO's and Emergency Short Service Commission Officers if such Ex-Officer had been the Ranks are entitled to stipends under the scheme.
- (III) The stipends admissible to all eligible children of Ex-serviceman.
