2. हरियाणा सरकार द्वारा यह निर्णय लिया गया है कि केन्द्रीय सशस्त्र बल कार्मिकों के वीरता / विशिष्ट / कर्तव्य के प्रति समर्पण पुरस्कार विजेताओं (अग्निवीर) को एकमुश्त नकद पुरस्कार प्रदान किया जाए।

3. वीरता/विशिष्ट/कर्तव्य के प्रति समर्पण पुरस्कार के लिए एकमुश्त नकद पुरस्कार की राशि संघीय सशस्त्र बल कार्मिकों के विजेताओं (अग्निवीर) को निम्नलिखित नियमों और शर्तों पर स्वीकार्य होगीः –

(1) युद्धकालीन वीरता पुरस्कार विजेताओं (अग्निवीर) को एकमुश्त नकद पुरस्कार की राशि:--

संघीय सशस्त्र बलों के कार्मिकों के युद्धकालीन वीरता पुरस्कार विजेताओं (अग्निवीर) को अनुदेशों के प्रकाशन पर या उसके बाद एकमुश्त नकद पुरस्कार की राशि निम्नानुसार होगी:–

नोट–1. एकमुश्त नकद पुरस्कार के अतिरिक्त कोई वार्षिकी या कोई अन्य लाभ स्वीकार्य नहीं होगा। युद्धकालीन पुरस्कार उन पुरस्कार विजेताओं पर लागू होते हैं जिन्हें घोषित युद्ध के दौरान पुरस्कार मिला हो।

- 2. बार का अर्थ है अग्निवीर को वीरता या कर्तव्य के प्रति समर्पण के किसी अन्य कार्य के लिए पुनः दिया गया पुरस्कार। पुरस्कार विजेता (अग्निवीर) जो एक ही पुरस्कार को एक से अधिक बार प्राप्त करता है, वह विभाग के अधिकार क्षेत्र के अंतर्गत सभी उद्देश्यों के लिए पुरस्कार के लिए लागू अतिरिक्त एकमुश्त नकद पुरस्कार का हकदार होगा।
- 3. एकमुश्त नकद पुरस्कार स्वीकार्य नहीं होगा, यदि भारत में किसी अन्य राज्य सरकार द्वारा पुरस्कार विजेता (अग्निवीर) को उस विशेष पुरस्कार के लिए अनुदान दिया गया हो।
- (4) परिभाषाएं: इस नीति में प्रयुक्त शब्दों को निम्नानुसार परिभाषित किया गया है:--
  - (क) 'हरियाणा राज्य से संबंधित' का तात्पर्य संघीय सशस्त्र बलों के ऐसे सदस्यों (अग्निवीर) से है जो रक्षा बलों में सेवा में शामिल होने / प्रवेश के समय हरियाणा राज्य के निवासी हैं, चाहे उनका वर्तमान आवासीय पता कुछ भी हो।
    - नोट.— यदि सेवा में शामिल होने के समय व्यक्ति का पता अस्थायी था, तो स्थानांतरणीय केंद्रीय सरकारी कर्मचारियों की तैनाती के स्थान के कारण, निवास की स्थिति उसके सेवा में शामिल होने के समय पिता के स्थायी घर के पते के आधार पर तय की जाएगी।
  - (ख) 'एकमुश्त नकद पुरस्कार' का तात्पर्य हरियाणा राज्य से संबंधित संघ सशस्त्र बल कार्मिकों के पुरस्कार विजेताओं (अग्निवीर) को स्वीकार्य एकमुश्त राशि से है।
  - (ग) 'पुरस्कार के मरणोपरांत दिए जाने या पुरस्कार विजेता (अग्निवीर) जो अपने जीवनकाल में दावा/प्राप्त नहीं कर सके, के मामले में एकमुश्त नकद पुरस्कार के अनुदान के प्रयोजनार्थ परिवार' पुरस्कार विजेता (अग्निवीर) के परिवार के सदस्यों/नोकों को एकमुश्त नकद पुरस्कार के अनुदान के प्रयोजनार्थ 'परिवार', मरणोपरांत दिए जाने या पुरस्कार विजेता (अग्निवीर) जो अपने जीवनकाल में दावा/प्राप्त नहीं कर सके, के मामले में निम्नानुसार होगा:–
    - (i) पति/पत्नी को 35%, भले ही उसने पुनर्विवाह किया हो या नहीं।
    - (ii) बच्चों को 35% (सभी बच्चों में समान रूप से विभाजित किया जाएगा)।
    - (iii) माता—पिता को 30% (माता को 15%, पिता को 15%), भले ही वे मृतक पर आश्रित हों या नहीं।
    - (iv) अविवाहित शहीद (अग्निवीर) के मामले में माता-पिता को 100% (माता को 50% और पिता को 50%)
    - (v) यदि मृतक कार्मिक(अग्निवीर) के कोई संतान नहीं है तो 50% विधवा (पति / पत्नी) को तथा 50% (25% + 25%) माता–पिता को)
    - (vi) यदि माता और पिता दोनों जीवित नहीं हैं तो 50% विधवा को तथा 50% बच्चों को।
    - (vii) यदि पिता या माता में से कोई जीवित है तो अनुग्रह राशि का हिस्सा उसे, जैसा भी मामला हो, जारी किया जाएगा।

- (viii) यदि विधवा (पति/पत्नी) जीवित नहीं है तो 50% माता–पिता को तथा 50% बच्चों को।
- (ix) यदि विधवा (पति / पत्नी) जीवित नहीं है तथा उसकी कोई संतान नहीं है तो 100% माता–पिता को।
- (x) यदि अविवाहित शहीद(अग्निवीर) के माता–पिता जीवित नहीं हैं तो अनुग्रह अनुदान का भुगतान आश्रित अविवाहित भाई / बहनों को किया जाना चाहिए, बशर्ते वे मृतक कार्मिक के जीवनकाल में उसके साथ रह रहे हों तथा शहीद पर पूर्णतः आश्रित थे।

नोट 1.- कोई अन्य पारिवारिक सदस्य / रिश्तेदार अनुग्रह अनुदान के लिए पात्र नहीं होगा।

 (घ) संघीय सशस्त्र बलों के कार्मिक' का तात्पर्य हरियाणा राज्य से संबंधित सेना, नौसेना, वायु सेना या भारतीय तटरक्षक बल के सदस्यों (अग्निवीर) से है।

#### (5) अनुग्रह अनुदान की स्वीकृति के लिए सक्षम प्राधिकारी और उसकी प्रक्रियाः

- (क) अनुग्रह अनुदान स्वीकृत करने के लिए सक्षम प्राधिकारी प्रशासनिक सचिव, सैनिक एवं अर्ध सैनिक कल्याण विभाग है और ऐसे मामलों को स्वीकृत करने की शक्तियां उपायुक्त–सह–अध्यक्ष, जिला सैनिक एवं अर्ध सैनिक कल्याण कार्यालय को सौंपी गई हैं और इसका भुगतान संबंधित उपायुक्त–सह–अध्यक्ष, जिला सैनिक एवं अर्ध सैनिक कल्याण कार्यालय द्वारा लाभार्थियों (अग्निवीर) के आधार लिंक्ड बैंक खातों में आरटीजीएस के माध्यम से किया जाएगा।
- (ख) संघीय सशस्त्र बलों के पुरस्कार विजेताओं को एकमुश्त नकद पुरस्कार स्वीकृत करने के लिए, जैसा भी मामला हो, इस नीति के अनुलग्नक ए और बी में उपलब्ध फॉर्म–1 या फॉर्म–2 में संबंधित जिला सैनिक और अर्ध सैनिक कल्याण अधिकारी को आवेदन प्रस्तुत करना होगा।
- (ग) पुरस्कार विजेता (अग्निवीर) से स्वयं या मृतक पुरस्कार विजेता (अग्निवीर) के परिवार के सदस्यों / परिचयकर्ताओं से आवेदन प्राप्त होने पर (यदि पुरस्कार मरणोपरांत दिया गया हो), इसे संबंधित जिला सैनिक एवं अर्ध सैनिक कल्याण अधिकारी द्वारा सत्यापित एवं जांचा जाएगा तथा मामला सैनिक एवं अर्ध सैनिक कल्याण विभाग, हरियाणा के निदेशक / महानिदेशक को चेक सूची (अनुलग्नक–सी पर उपलब्ध फार्म–3) के अनुसार सभी दस्तावेजों की प्रमाणित प्रतिलिपियों के साथ उनकी टिप्पणियों सहित स्वीकृति जारी करने एवं आर्री करने एवं ऑनलाइन बजट जारी करने के लिए प्रस्तुत किया जाएगा।
- (घ) निदेशक / महानिदेशक, सैनिक एवं अर्ध सैनिक कल्याण विभाग, हरियाणा के कार्यालय में मामले की प्राप्ति पर, इसकी जांच की जाएगी और स्वीकृति के लिए प्रशासनिक सचिव को प्रस्तुत किया जाएगा तथा जिला सैनिक एवं अर्ध सैनिक कल्याण अधिकारी को पुरस्कार विजेता (अग्निवीर) या मृतक पुरस्कार विजेता (अग्निवीर) के परिवार के सदस्यों / परिचयकर्ताओं को एकमुश्त नकद पुरस्कार के भुगतान के लिए ऑनलाइन बजट जारी किया जाएगा, यदि स्वीकृत हो और इसकी प्रतिलिपि संबंधित अधिकारियों / प्राधिकारियों / लाभार्थियों आदि को भेजी जाएगी।
- (ड) सम्पूर्ण अभिलेख (एकमुश्त नकद पुरस्कार की स्वीकृति से सम्बन्धित दस्तावेज) तथा एकमुश्त नकद पुरस्कार राशि के भुगतान को जिला सैनिक एवं अर्ध सैनिक कल्याण कार्यालय के सम्बन्धित कार्यालय में सुरक्षित रखा जाएगा। वे इन दस्तावेजों की सॉफ्ट कॉपी भी सुरक्षा एवं अभिलेख हेतु अपलोड करेंगे।
- (6) व्यय का वर्गीकरण

संधीय सशस्त्र बलों और केंद्रीय सशस्त्र पुलिस बलों के पुरस्कार विजेताओं या मृतक पुरस्कार विजेताओं के परिवार के सदस्यों / परिजनों को एकमुश्त नकद पुरस्कार के लिए व्यय मुख्य शीर्ष ""2235–सामाजिक सुरक्षा और कल्याण (गैर योजना)–60–अन्य सामाजिक सुरक्षा और कल्याण कार्यक्रम–200–अन्य कार्यक्रम (95)–59– पुरस्कार और सम्मान – कश्मीर अभियान आदि में वीरता के कार्यों के लिए सैनिकों, नौसैनिकों और वायुसैनिकों को पुरस्कार" (पी–01–16–2235–60–200–95–51–आर–वी–59–पुरस्कार और सम्मान (गैर योजना) – मांग संख्या 16) के अंतर्गत पूरा किया जाएगा।

.(7) कठिनाइयों को शिथिल करने या दूर करने की शक्तिः– यदि इस नीति के आवेदन, व्याख्या और दायरे से संबंधित कोई संदेह उत्पन्न होता है, तो इसे सैनिक और अर्ध सैनिक कल्याण विभाग (रक्षा– III शाखा), पंचकूला में हरियाणा सरकार को भेजा जाएगा। हरियाणा सरकार, सैनिक और अर्ध सैनिक कल्याण विभाग, हरियाणा के प्रशासनिक सचिव को संदेह (शंकाओं) की व्याख्या, परिवर्तन, संशोधन, शिथिलता और हटाने की शक्ति होगी, और उनका निर्णय अंतिम होगा।

**No. 51/11/2025-4D-III.**— Regarding grant of onetime cash award to Gallantry//Distinguished/Devotion to Duty award winners (Agniveer) of Union Armed Forces personnel belonging to Haryana State.

2. It has been decided to issue instructions by the Government of Haryana that grant of onetime cash award to Gallantry/Distinguished/Devotion to Duty award winners (Agniveer) of Union Armed Forces personnel.

3. The amount of onetime cash award for Gallantry/Distinguished/Devotion to Duty award shall be admissible to the award winners (Agniveer) of Union Armed Forces personnel on the following terms and conditions:-

#### (1) Amount of onetime cash award to War time Gallantry award winners (Agniveer):-

The amount of onetime cash award for War time Gallantry award winners (Agniveer) of Union Armed Forces personnel on or after publication of instructions shall be as under:-

# (3) Amount of onetime cash award to Peace time Distinguished/ Devotion to Duty award winners (Agniveer):-

The amount of onetime cash award for Peace time Distinguished/Devotion to Duty award winners (Agniveer) of Union Armed Forces personnel on or after publication of instructions shall be as under:-

**Note -1.** No Annuity or any other benefit shall be admissible in addition to Onetime Cash Award. War time awards are applicable to awardees who get award during declared war. Previous cases shall not be reopened. All beneficiaries, who have been sanctioned Annuity prior to issue of this letter, shall also get the Annuity at enhanced rates as per policy/instructions No. 20/4/95-4D-III dated 28.05.2014 without referring to this Headquarters.

- 2. Bar means an award given to the Agniveer again for another act of Gallantry or Devotion to Duty. Awardee (Agniveer) who receives the same award more than once be entitled to additional onetime cash award as applicable to the award for all purposes under purview of the Department.
- 3. Onetime cash award will not be admissible, if such grant has been given by any other State Government in India to the awardee (Agniveer) for that particular award.
- (4) **Definitions**: The terms used in this policy have been defined as under:-
  - (a) **'Belonging to Haryana State'** means such members (Agniveer) of Union Armed Forces who are domicile of Haryana state at the time of joining/entry into the service in Defence Forces irrespective of their present residential address.
    - **Note** In case individual's address at the time to joining service was a temporary one, due to the place of posting of transferable Central Government employees, the domicile status would be decided on the basis of his father's permanent home address at the time of his joining service.
  - (b) 'Onetime cash award' means the lump sum amount admissible to the award winners (Agniveer) of Union Armed Forces personnel belonging to Haryana State.
  - (c) 'Family for the purpose of grant of onetime cash award in case of award given posthumously or awardee (Agniveer) who could not claim/ receive in their life time' The 'Family' for the purpose of grant of onetime cash award to family members/NoKs of award winner (Agniveer), in case of award given posthumously or awardee (Agniveer) who could not claim/ receive in their life time shall be as under:-
    - (i) Spouse @ 35% irrespective of the fact that she/he has remarried or not.
    - (ii) Children @ 35% (To be equally apportioned among all the children).
    - (iii) Parents @ 30% (Mother @ 15%, Father @ 15%) irrespective of the fact that they are/were dependent on the deceased or not.
    - (iv) In case of unmarried deceased awardee (Agniveer), Parents @ 100% (50% to Mother and 50% to Father).
    - (v) In case the deceased awardee (Agniveer) did not have any children then 50% to Spouse and 50% (25% + 25%) to Parents.
    - (vi) If both Mother and Father are not alive then 50% to Spouse and 50% to Children.
    - (vii) If either Father or Mother is alive then the share of onetime cash award amount is to be released to him/her as the case may be.
    - (viii) If spouse is not alive then 50% to Parents and 50% to Children.
    - (ix) If spouse is not alive and have no child then 100% to Parents.
    - (x) In case of Parents of unmarried awardee (Agniveer) are not alive the payment of onetime cash award should be made to the dependent unmarried brother (s) and unmarried sister (s) provided they were residing with the deceased awardee during his lifetime and was/were fully dependent on the deceased awardee (Agniveer).
      - Note.-No other family member/relatives shall be eligible for onetime cash award amount.
  - (d) **'Personnel of Union Armed Forces'** means a members (Agniveer) of Army, Navy, Air Force or Indian Coast Guard belonging to State of Haryana.
- (5) Competent Authority for sanction of onetime cash award and procedure thereof:
  - (a) The competent authority to sanction of onetime cash award to award winners (Agniveer) is the Administrative Secretary, Sainik and Ardh Sainik Welfare Department, Haryana and payment of which shall be made by the concerned Deputy Commissioner-cum-President, District Sainik and Ardh Sainik Welfare Office through RTGS in Aadhar linked bank accounts of the beneficiaries.
  - (b) For sanction of onetime cash award to award winners (Agniveer) of Union Armed Forces, as the case may be, he/she shall submit an application in the Form-1 or Form-2, available at Annexure A and B of this policy, to the concerned District Sainik and Ardh Sainik Welfare Officer.

- (c) On receipt of application from award winner (Agniveer) himself or from the family members/NoKs of deceased award winners (Agniveer) (in case of award was given posthumously, it will be verified and scrutinized by the concerned District Sainik and Ardh Sainik Welfare Officer and case will be submitted to the Director/Director General, Sainik and Ardh Sainik Welfare Department, Haryana along with certified true copy of all the documents as per check list (Form-3 available at Annexure C) along with their comments for issue of sanction and release of online budget.
- (d) On receipt of matter in the office of the Director/Director General, Sainik and Ardh Sainik Welfare Department, Haryana, it will be examined and submitted to the Administrative Secretary for sanction and online budget will be released to the District Sainik and Ardh Sainik Welfare Officer for payment of onetime cash award to award winner (Agniveer) or to the family members/NoKs of deceased awardee (Agniveer), if approved and copy will be sent to the concerned officers/authorities/beneficiaries etc.
- (e) The entire record (Documents related to sanction of onetime cash award) and payment of onetime cash award amount will be kept in safe in the concerned office of District Sainik and Ardh Sainik Welfare Office. They will also upload the soft copy of these documents for safety and records.

#### (6) **Classification of expenditure:**

The expenditure for onetime cash award to award winners or family member (s)/NoKs of deceased awardee of Union Armed Forces and Central Armed Police Forces will be met under the Major Head "2235-Social Security and Welfare (Non Plan)-60-Other Social Security and Welfare Programmes-200-Other Programmes (95) -59-Prizes and Awards - Rewards to Soldiers, Sailors and Airmen for acts of gallantry in the Kashmir Campaign etc" (P-01-16-2235-60-200-95-51-R-V-59-Prizes & Award (Non Plan) - Demand No. 16.

#### (7) **Power of relax or remove the difficulties:-**

If any doubt (s) arises relating to the application, interpretations and scope of this Policy, it shall be referred to the Government of Haryana in Sainik and Ardh Sainik Welfare Department (Defence-III Branch), Panchkula. The Administrative Secretary to Govt. of Haryana, Sainik and Ardh Sainik Welfare Department, Haryana will have the power to interpret, change, amend, relaxation and removal of doubt (s), and whose decision shall be final.
