The Government of Haryana has established the Department of Future (*Bhavishya Vibhag*), and the Finance Department, Government of Haryana, has sanctioned 35 regular staff posts for the operationalization of the Directorate of Future.

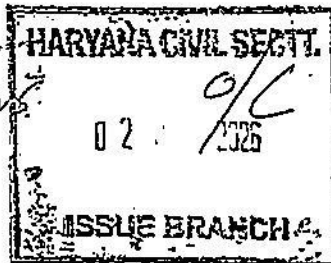
3. **Terms & Conditions for Deputation:**The initial period of deputation will be for one year, extendable as per standard instructions of the State Government, or until regular recruitment takes place, whichever is earlier. The selected candidates will draw their pay and allowances in their respective parent pay scales, and their terms of service will be governed by standard Haryana Civil Services rules.

4. **Application Procedure:**It is requested that willing and eligible employees may forward their applications through the proper channel along with their summary of past 5 years' ACRs, and a clear "No Objection Certificate" (NOC) stating that no disciplinary or vigilance proceedings are pending against them. However, the final selection will only be completed upon receipt of the physical application through the proper channel via post.
