Subject: **Haryana State Accounts Service Examination (HSAS) (Ordinary Branch), Part-I and Part-II.**

1. I am directed to invite a reference to the subject noted above and to inform that Haryana State Accounts Service Examination, Part-I and Part-II (OB) is likely to be held in the month of October/November, 2026. The exact schedule and venue for holding HSAS(OB) Part I and Part-II Examination will be notified in due course.
2. Applications are invited online from amongst regular employees of organizations working on a post Group B or C or equivalent post, possessing prescribed qualification and experience as per instructions/guidelines/regulation for conducting SAS Part-I and Part-II examination issued by the Government vide letter No. 14/30/2021-IFA dated 06/02/2023, corrigendum dated 20.06.2024 and Haryana State Accounts Subordinate (Group C) Service Rules, 2022.
3. The Head of the Department or any officer authorized by Head of Department not below the rank of Additional Director of concerned employee shall certify that: -
  - (i) The candidate is efficient and is likely to pass the examination.
  - (ii) The integrity of the candidate is above board as per instructions issued by the Chief Secretary, Haryana vide their letter No. 2759-4GSI-73/12854, dated 21.05.1973 and further amended from time to time.
  - (iii) The candidate has obtained 70% or more reports of "Good" or above grading during the last 10 years. In case the service of the candidate is less than ten years, then the criteria for ACR shall be in accordance with the length of service of the candidate.
4. Employees regularized under the State Government Policy No. 6/7/2014-IGSI, dated 16.06.2014, 18.06.2014, 07.07.2014 and 28.07.2014 shall be allowed to participate in the examination on provisional basis as at present there is no instructions to date has been issued by Government in view of Supreme Court judgement dated 16.04.2026 in SLP No. 31566 of 2018 titled as State of Haryana & others Vs Yogesh Tyagi and others.
5. If eligibility of any candidate is doubtful or subject to any proceedings/orders of any Court of Law, he/she shall not be eligible for this examination.
6. The Administrative Secretary to Government of Haryana, Finance Department reserves the right to reject any application for appearing in the Examination by giving duly recorded reasons thereof.



7. The fee for the examination is Rs. 3000/- (Rupees Three Thousand only). The same should be remitted by the candidates while submitting forms online through any one of the payment mode available in E-GRAS by selecting **Director Treasuries & Accounts Department, Haryana (DDO Code:0581)** in receipt Head of Account "**0070-60-800-95-51 Other Fees, fines and forfeitures**" by selecting payment type as fee. No application will be entertained without requisite fee.
8. The following instructions should be kept in view by the Head of Department or any officer authorized by Head of Department not below the rank of Additional Director while verifying/certifying the application: -
  - a) The application should be complete in all respects; incomplete applications will not be entertained.
  - b) All particulars entered in the application should be duly certified/verified by the Head of Department as per service book/record of the candidate.
  - c) Head of Universities/Boards/Corporations/Federations/Authorities will also certify that the organization is wholly owned (100%) and controlled by the State Govt. as per Explanation mentioned in para 3 of the Regulation.
  - d) The employees of Constitutional Bodies namely, Haryana Vidhan Sabha, Haryana Public Service Commission, Punjab & Haryana High Court/District Court etc. who want to appear in the HSAS Examination, may be allowed subject to the condition that they shall submit an affidavit to the effect that they will not lay any claim for appointment to the Haryana State Accounts Subordinate Group C" Service Cadre on the basis of their participation and successfully passing the examination. Further their appointment will be subject to the vacancies existing in their respective organization. Result of such candidates will be declared separately.
9. The requisite document/certificates of the candidates will be verified after qualifying the HSAS Part-II exam. If any fact, submitted by the candidate, is found incorrect at any stage his/her candidature is liable to be cancelled.
10. **It is mandatory to fill Family Id/Temporary Family Id (Parivar Pehchan Patar) provided by Haryana Parivar Pehchan Authority while submitting the application form.**
11. The instructions/guidelines/regulation for conducting SAS Part-I and Part-II examination issued by the Government vide letter No. 14/30/2021-1FA dated 06/02/2023 and Haryana State Accounts Subordinate (Group C) Service Rules, 2022 should be kept in view while applying for the said examination.
11. Other terms and conditions w.r.t. candidature and service will be governed by the Revised Regulations issued by Finance Department vide its letter No. 14/30/2021-1FA, dated 06.02.2023 which are available [www.finhry.gov.in](http://www.finhry.gov.in) and [www.hrtreasuries.gov.in](http://www.hrtreasuries.gov.in).
12. The application forms complete in all respects and duly verified by the Head of Department should be uploaded by 30.07.2026 on SARAL Web Portal(<http://saralharyana.gov.in>). The online portal will start on 15.07.2026 at 09:00AM and closed on 30.07.2026 at 11:59 PM. No application will be entertained in any form after the closing date.
