
I am directed to invite a reference to this department U.O.No.43/4/2008-6SII, dated 10.9.2008 (copy enclosed) on the subject mentioned above and to say that this matter has been further considered by the Government and it has been decided that the Land Acquisition Officers posted at Gurgaon, Faridabad, Rohtak, Panchkula and Hisar will be reserved for the Urban Estates Department and work under the administrative control of the Urban Estates Department. These five posts will be manned by the HCS officers. They would draw their salary from the Urban Estates Department and function from Urban Estates Offices. They would be assisted by the Urban Estates staff.

In addition, these Land Acquisition Officers will look after the land acquisition work pertaining to other departments as under:-

Land Acquisition Officer, Gurgaon	Gurgaon and Mewat districts
Land Acquisition Officer, Faridabad	Faridabad and Palwal districts
Land Acquisition Officer, Rohtak	Rohtak and Jhajjar districts
Land Acquisition Officer, Panchkula	Panchkula, Yamunanagar and Ambala districts
Land Acquisition Officer, Hisar	Hisar and Bhiwani districts

2. The Land Acquisition Officers at Rewari (for Rewari and Mahendergarh districts), Sirsa (for Sirsa and Fatehabad districts), Kaithal (for Kaithal and Jind districts), Karnal (for Karnal and Kurukshetra districts) and Panipat (for Panipat and Sonipat districts) would look after the land acquisition work pertaining to various departments in their respective areas of jurisdiction. They would work under the direct supervision of Deputy Commissioners concerned. The Revenue and Disaster Management Department would provide requisite staff and budget for the effective functioning of these Land Acquisition Officers.

Subject:- Posting of Land Acquisition Officers in the State.

Will the Financial Commissioner & Principal Secretary to Government, Haryana, Revenue and Disaster Management Department kindly refer to the subject mentioned above?

2. It is informed that prior to 13.8.2008, there were 11 posts of Land Acquisition Officers of the HCS(Executive Branch) cadre:-

Permanent Posts

1. Land Acquisition Officer, PW (B&R), Ambala
2. Land Acquisition Officer, PW (B&R), Hisar
3. Land Acquisition Officer, Urban Estate, Panchkula
4. Land Acquisition Officer, Urban Estate, Gurgaon
5. Land Acquisition Officer, Urban Estate, Faridabad

Temporary Posts

6. Land Acquisition Officer, PW (B&R), Bhiwani
7. Land Acquisition Officer, PW (B&R), Gurgaon
8. Land Acquisition Officer, PW (Irrigation), Ambala
9. Land Acquisition Officer, PW (Irrigation), Bhiwani
10. Land Acquisition Officer, Urban Estate, Hisar
11. Land Acquisition Officer, Power, Ambala

In addition, one post of Land Acquisition Officer, Urban Estate, Rohtak was created by the Town & Country Planning Department.

3. The State Government has reviewed the composition and strength of HCS (EB) cadre and has fixed the strength of the HCS cadre as 220 posts vide order dated 13.8.2008 issued vide Endst. No. No. 43/4/2008-6SII, dated 13.8.2008. Six posts of Land Acquisition Officer have been decadred from the HCS cadre and at present there are only following five posts of Land Acquisition Officer of the HCS cadre:-

1. Land Acquisition Officer, PW (B&R), Ambala
2. Land Acquisition Officer, PW (B&R), Hisar
3. Land Acquisition Officer, Urban Estate, Panchkula
4. Land Acquisition Officer, Urban Estate, Gurgaon
5. Land Acquisition Officer, Urban Estate, Faridabad.

4. Now for the smooth functioning of the work of land acquisition in the State, a decision has been taken that there will be ten posts of Land Acquisition Officers for the work of the land acquisition in the State as under:-

1. Land Acquisition Officer Panchkula (for the districts of Panchkula, Yamunanagar and Ambala)
2. Land Acquisition Officer, Hisar (for the districts of Hisar and Bhiwani).
3. Land Acquisition Officer, Gurgaon (for the districts of Gurgaon and Mewat).
4. Land Acquisition Officer, Faridabad (for the districts of Faridabad and Palwal).
5. Land Acquisition Officer, Rohtak (for the districts of Rohtak and Jhajjar).
6. Land Acquisition Officer, Rewari (for the districts of Rewari and Mahendragarh).
7. Land Acquisition Officer, Sirsa (for the districts of Sirsa and Fatehabad).
8. Land Acquisition Officer, Kaithal (for the districts of Kaithal and Jind).

9. Land Acquisition Officer, Karnal(for the districts Karnal and Kurukshetra).
 10. Land Acquisition Officer ,Panipat(for the districts Panipat and Sonapat).

It has further been decided that the following posts of Land Acquisition Officers will be of the HCS cadre and HCS officers will be posted on these posts:-


1. Land Acquisition Officer, Faridabad

He is requested to declare the work jurisdiction of the Land Acquisition Officers by issuing an appropriate order/notification. and to post the District Revenue Officers on these five posts of Land Acquisition Officers accordingly.


